Your firm has been certified under NAICS code 541519, Other Computer Related Services. Based upon your firm's description of services and past work performance on the DBE applications submitted, your firm performs computer disaster recovery services & software installation services, computer. Other Computer Related Services is too broad and not the most accurate description of your firm's primary activities, therefore 541519, Other Computer Related Services was removed from your firm's certification and replaced with the more accurate NAICS code and description of 541519, Computer disaster recovery services; Software installation services, computer.
